Fee Resolution**

**A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF
SPRINGFIELD, MERCER COUNTY AMENDING AND REVISING THE SCHEDULE
OF FEES PER TOWNSHIP ORDINANCES**

WHEREAS, various ordinances of the Township of Springfield allow for the setting of fees by Resolution to defer the cost of their administration; and

WHEREAS, the Springfield Township Board of Supervisors are desirous of establishing a schedule of fees in a single document; and

WHEREAS, in keeping with good practice, the Board of Supervisors periodically reviews the schedule of fees and makes appropriate revisions thereto; and

WHEREAS, the Springfield Township Board of Supervisors has determined that certain revisions are necessary and in the best interest of the Township;

NOW THEREFORE, let it be resolved and enacted that a schedule of fees be established as contained herein and that this Resolution shall replace all previous fee schedule resolutions.

Taxes

Pennsylvania Education and Training Program Fee

A \$4.50 fee regulated by Labor and industry shall be assessed on each permit issued. Fees collected under this section shall be sent to the State Treasury according to Act 45 of 1999, as amended. (Note: Act 157 of 2006 increases fee)

Building permit and application review fees

Fees shall be assessed according to the fee schedule, inspection and administration services of the Third-Party Administrator. (See Exhibit “B”).

Township Administration Fee

\$25 shall be assessed on each residential building permit issued for Township Administration costs. Commercial construction permits shall be assessed at \$0.10 per square foot for the Township Administration costs.

Zoning Permit Fee

\$25.00 for the first \$5,000 of the cost of the structure, plus \$1.00 for each additional \$1,000 of cost, or portion thereof.

Subdivisions

Minor Subdivision \$50.00 plus \$25.00 per lot
Major Subdivision \$500.00 plus \$50.00 per lot

Land Developments

- Mobile Home or Recreational Vehicle Park \$2,000 plus \$25.00 per unit
- 2nd or 3rd detached single-family residence on a parcel \$50.00 plus \$25.00 per unit/tenant
- Single Parcel less than ½ acre \$1,000 plus \$25.00 per unit/tenant
- Single Parcel ½ to 1 acre \$1,500 plus \$50.00 per unit/tenant
- Single Parcel larger than 1 acre \$2,000 plus \$50.00 per unit/tenant
- Multiple Parcels up to 1 acre \$2,000 plus \$50.00 per unit/tenant
- Multiple Parcels over 1 acre \$2,500 plus \$50.00 per unit/tenant

Application Deposit

Upon initial submission of any application under this heading, in addition to the application fee, the applicant shall make a deposit to the Township as follows:

From this amount shall be deducted any fees accruing from Township consultants and/or Township Solicitor reviews. If at any time during the progression of an application it is determined by the Township that the balance available is or will be inadequate to fully cover anticipated review costs, the applicant will be notified that an additional deposit is required equal to the first deposit. At the completion of any project and after the final bond release request by the Township Board of Supervisors, any of these monies remaining on deposit with the Township, after all fees are deducted, shall be returned to the applicant.

Recording of the Plan and Fees

At the time of approval of final application, the Developer will obtain Mercer County Regional Planning review and record the Plan with the Mercer County Recorder's Office. The Developer will return one mylar stamped by the Recorder to the Township.

Sign Application and Permit Fee

Single Sign up to 32 square feet is \$100.00. Multiple Signs on property or signs over 32 square feet are \$150.00 plus \$2.00 per each additional square foot of signage.


Motor Vehicle Weight Limitation and Road Bonding Inspection Fee


In addition to any fees or charges referenced in the Springfield Township Motor Vehicle Weight Limitation Ordinance 3-2010 or the Statutes and Regulations, the following fees or charges shall be imposed under said Ordinance.

1. Application Administration Fee: Type 1 & Type 2 Permits: \$50.00; Type 3 Permits: \$15.00
2. Initial and Final Inspection Fee: \$150.00 for Initial and Final Inspections consisting of up to 1 hour each.
3. Any time over 1 hour of inspection: \$50.00 per hour
4. Roadway Condition Surveys: \$50.00 per hour
5. Interim Inspections: \$50.00 per hour
